## JCC of Mid-Westchester Camps Registration Agreement

- A.1 The parent or guardian signing this Registration Agreement acknowledges that the Camp shall have the right to make all decisions regarding the child's fitness to participate in particular activities or the entire Camp program.
- A.2 At any time before opening day of the Camp season, the Camp shall have the right to cancel this Registration Agreement if it determines, in its sole judgment: (a) that the physical, mental, or emotional condition of the child would prevent him/her from participating safely and satisfactorily in the Camp program or interacting positively with other children at the camp or (b) the child's parent(s) or guardian(s) make a request that cannot be implemented.
- A.3 Once camp has begun, the Camp shall have the right to terminate this Registration Agreement and the child's enrollment in Camp and dismiss the child if it determines, in its sole judgment (a) that the child exhibits unacceptable behavior which prevents the Camp staff from safely supervising the child or proves detrimental to himself/herself other campers, or Camp staff or property or (b) the child's parent(s) or guardian(s) make an unreasonable demand upon the Camp. Should such action be taken by the Camp, no refund will be made and the parent or guardian who signs this Registration Agreement will remain responsible for all amounts due the Camp as if the child's enrollment in Camp had continued and the child had not been dismissed.
- 4A. The parent or guardian signing this Registration Agreement agrees to advise the Camp Directors promptly in writing of any change in the child's physical or mental health between the date of enrollment and the start of the Camp session as well as throughout the Camp session.
- B. The parent or guardian signing this Registration Agreement represents to the Camp that written in the space below is his/her child's history of medical conditions or surgical procedures, therapy programs, and/or regularly-taken prescription medication:

The parent or guardian signing this Registration Agreement represents to the Camp that except as noted above the child is in sound physical and mental health and fully able to participate in all Camp activities without need of individual or specialized attention or medical regimen and that the child's health will not impinge or impact negatively of other campers or the Camp program.

- C. In case of medical emergency, the parent or guardian signing this Registration Agreement hereby gives permission to the physician selected by the Camp Director to hospitalize, secure, proper treatment for, and to order injection, anesthesia, or surgery for the child. Note that in an emergency, it is Camp policy to make every effort to contact the parent or guardian in advance.
- D. Unless the Camp is restricted by a court order directed expressly to the Camp, (i) the parent or guardian signing this Registration Agreement hereby authorizes the Camp to release the child to either parent (or persons authorized by either parent or the guardian) on Camp property at any time during the day if arrangements for pick-up of the child have been made beforehand with the Camp office even if both parents do not live at the same address, and (ii) to permit both parents to visit the child at the Camp. Note that disputes between parents which involve the Camp in any way must be resolved immediately by the parents, failing which the Camp shall have the right to terminate this Registration Agreement and the child's enrollment in Camp and dismiss the child. Should such action be taken by the Camp, no refund will be made and the parent who signs this Registration Agreement will remain responsible for all amounts due the Camp as if the child's enrollment in Camp had continued and the child had not been dismissed.
- E. The parent or guardian signing this Registration Agreement (i) irrevocably authorizes and consents to the Camp's use of the child's name, photograph, portrait, or image in connection with the Camp's brochure or other promotional or advertising materials and to the Camp's use of a child's and/or child's family's home address and phone number for groups, playdates and car pool lists, (ii) releases the Camp from any liability for such use, and (iii) agrees to indemnify and hold the Camp harmless from and against any and all liabilities, damages, losses, costs, and/or expenses (including reasonable attorney's fees and expenses) arising from such use.
- F. The parent or guardian signing this registration agreement acknowledges that the limits of the camp's health and accident insurance liability is that in the event of an accident, all claims must be filed initially with the parent's or guardian's individual insurance carrier and that the camp's insurance will only cover deductibles and any other amounts not covered by private insurance, up to a limit of \$5,000.
- G. The parent or guardian signing this Registration Agreement Acknowledges that the Camp is not responsible for the child's personal property.
- H. The parent or guardian signing this Registration Agreement hereby gives permission for the child to attend all trips and special programs during the Camp season.
- I. The parent or guardian who signs this Registration Agreement specifically agrees to be responsible for payment of all fees charged by the Camp. No refund will be made at any time after March 29, 2019.
